1. Welcome & Lunch
 2. Approve minutes from previous month
 - a. printed draft of minutes available

 3. This month's business
 - a. School Behavior Prevention Plan-Mrs. Stubbs
 - i. Mrs. Stubbs presented information on House Bill 58. It requires our school to have a plan to address tobacco, alcohol, e-cigarette products and other controlled substance use. It is state mandated and is a subsection of our Positive Behavior Interventions and Supports. These issues will be addressed during Red Ribbon Week (Oct. 24-28), Friendship Week, CLIMB class, assemblies, and through classroom counselor lessons.
 - ii. Positive Behavior Plan programs in place at Mt. Loafer are: Altitude Awards, Student Council, Great Grizzlies, PBIS, and other PTO sponsored activities.
 - iii. Council discussed the necessity of addressing appropriate/inappropriate language and touching as we have seen an increase in these behaviors.
 - iv. Council also discussed adopting a district approved program for Mrs. Rasmussen to teach during the CLIMB class, but it was decided that we will table this decision until a later date.
 - b. Review Reading Acadience Data EOY and BOY
 - i. 2021-2022 End Of Year data showed that 69% of Mt. Loafer students are performing at or above grade level. Beginning Of Year data for 2022-2023 shows 61% of students performing at or above level in reading. Targeted interventions are being provided for students performing below level through Special Education, or intervention from one of the certified intervention teachers funded by Trustlands funds, or by the classroom teacher. All students below level (red or yellow on Acadience benchmark) are receiving some type of intervention and will be progress monitored.
 - c. Discuss grade level goals
 - i. Each grade level set goals for EOY 2022-2023 for each class/grade level. Schoolwide goal is having 83% of students at or above grade level by EOY. Teachers will be setting individual goals with students.
